Minutes of the meeting held on Wednesday 8th April 2020 via email.

2879: Declaration of interests: None

2880: Public forum: deferred until meetings in public recommence.

2881: Minutes: On Wednesday 26th February 2020: The minutes were agreed as a true record. To be signed once meetings in public commence.

2882: Matters Arising and Actions:

2883: Coronavirus how it effects Parish Council meetings:

A: Monthly Parish Council Meetings: In line with Government COVID-19 legislation the PC have cancelled all future meetings for the time being. On this occasion matters requiring decisions will be decided after emails between the Parish Councillors by the Chairman/Vice Chairman in consultation with the Clerk.

B: Parish 2020 AGM. - will be deferred until (including electing Chairman & Vice Chairman) until further notice.

C: Annual Meeting of Parish Council – is cancelled as public meetings are not possible.

Update from the Parish Clerk: Letter from MHCLG to Local Authority chief executives on emergency legislation to support local authorities.

The first set of regulations enables all local authority meetings before 7 May 2021 to be held remotely and removes the requirement for the annual meeting this year.

The second set of regulations postpones until 6 May 2021 local by-elections and other polls, either scheduled or which would otherwise arise before that date.

D: Planning Applications. The Parish Council propose to review/ comment on current planning applications via email as applications are still being processed by TDC – hoping for guidance from EALC & TDC Planning. Mr. R Colley proposed: we should continue to comment on applications sincee TDC will determine them as usual. All agreed.

E: Internal & External Audit.

Parish Clerk reported Following NALC's engagement with government around local council audit time frames final regulations are due to be made the week commencing 6 April which will extend the statutory audit deadlines for 2019/20. It is proposed that:

- The publication date for final, audited, accounts for local councils will move from 30 September to 30 November 2020
- To give local councils more flexibility, the requirement for the public inspection period to include the first 10 working days of July has been removed. Instead, local councils must commence the public inspection period on or before the first working day of September 2020. This means that draft accounts must be approved by 31 August 2020 at the latest or maybe approved earlier where possible.

2884: Coronavirus Village Facilities: To note the Playing Field, the Village Hall and the Church have been closed until further notice.

2885; Coronavirus keeping in touch: Keeping in touch during the social isolation period via Village Newsletter and Website. Following this virtual meeting a new edition of the Village Newsletter will be finalised, published and delivered by volunteers to keep in touch with residents not on Facebook or the internet. Richard Colley will produce the next edition

The new Parish Council web site was launched during March and is including local topical news items. It has received 615 visits to date.

2886: Coronavirus Community Shop: The Parish Council would like to thank the Community Shop volunteers for supporting the community during the social isolation period. The Wrabness Hub was established at the shop by Bev, Debs & Zoe with volunteers to support vulnerable residents. Currently supporting 30 households.

2887: TDC support for volunteer activity COVID-19: A one off TDC grant of £400 has been awarded to Wrabness Community Shop. This was arranged by the Parish Council via District Councillor Zoe Fairley who had an allocation of £1000 for good causes in the three parishes comprising the Stour Valley Ward.

2888; **Grant Application: Wrabness Community Shop:** To determine the grant application received from the Shop for £500 to support for the additional expenses incurred offering charitable support to the community in addition to Community Shop Service during the COVID-19 Virus crisis. — It was proposed to grant the full £500. All agreed. **Action: Mr R Colley**

2889: Open space, land South of Station Road, Wrabness: Parish Council held an informal meeting with Bennett Homes on 10th March. At that meeting it was confirmed the open space will be laid out ready for use and the freehold of the land will be transferred to the Parish Council as a gift. It was noted that no money is on offer to the Parish Council towards the ongoing maintenance costs. TDC is progressing the variation to the Section 106 planning agreement to support the transfer and laying out of land to the Parish Council.

2890: Planning Applications:

A: 20/00140/FUL -Ness House Ash Street Wrabness Manningtree Essex CO11 2TG - Proposed erection of a two-bay Cart Lodge and Store Shed - revised application following the withdrawal of 19/00739/FUL.

Mr R Colley declared an interest and took no part in the matter. The voting was split, the majority voted No Objection.
