WRABNESS PARISH COUNCIL

Minutes of the meeting held on Wednesday 19th February 2020 in Wrabness Village Hall at 7.30pm

Present: Mr. R Colley (Vice Chairman), Ms. R Thornton, Mrs. J Cole. Mrs. L Byrne.

In Attendance: Mrs. C Greenwood (Parish Clerk), 5 members of the public.

2861: Apologies for absence: Mr. M. Cole (Chairman), Mr. H Jones, Mr. F. McGowan.

2862: Declaration of interests: None

2863: Public forum: The Council invited members of the public to address the Council, raise or ask questions on matters relating to the parish. The Council reserved the right not to answer questions but will respond in writing as soon as it is practical after the meeting.

i. A member of the public raised concern about grazing land to the north west of Wheatsheaf Lane and Wall Lane. The issue is that the main surface water channel crossing the land is overgrown and needs dredging. The channel takes surface water from surrounding land which discharges through a tidal sluice to the River Stour. Anglian Water and latterly the Environment Agency undertook regular maintenance dredging of the drainage channel but this has been discontinued due to budget cuts. The channel now has reduced flow and capacity and after rainfall the grazing land becomes flooded over extended periods. The waterlogged fields are less suitable for grazing and the natural habitat is changing. Another member of public commented that she hasn't seen any kingfishers, frogs or a number of other species there recently.

A member of the public said a covenant exists requiring the various owners to grant access for maintenance dredging and not to impede the flow of water. Essex Wildlife Trust has created scrapes from the channel to retain water on their land which is affecting adjacent grazing land and this could be in breach of the covenant.

Parish Council response: The flooding of the land and lack of maintenance of the drainage channel is a matter of public concern and the Council can contact the Environmental Agency on the matter. It is desirable that the various land owners jointly manage the land to best effect for grazing and nature conservation and the Council could seek advice from Essex Wildlife Trust. The Parish Council has no powers relating the covenants attached to land title; these are private legal matters between the parties involved.

ii: A member of the pubic attended the meeting to offer to reinstate the rotten stile at the entrance to Essex Way next to Steeplefield, Ash Street.

Parish Council response: Thank you, the community and footpath users will benefit from this generous offer.

iii: A member of the public raised concerns about crime and drew attention to the recent burglaries of three homes, speeding vehicles, vandalism and the anxiety this creates particularly for the elderly living alone. Suggestions made included more security for the shop, village hall and church, white gates to the entrance of the parish might help to identify the locality as a community, signs to entrance of the village, for example 'we welcome careful drivers', as well as CCTV cameras along the foreshore and near the shop to deter crime.

Parish Council response: The Parish Council would like to see more Police patrols through the village to deter crime. The upgrading of security needs to be kept under review by all property owners. Speed limits, signage and gates are matters that can be raised by the Council with ECC the highway authority, providing it does not create clutter in the countryside. CCTV cameras are permissible on private property; there are strict controls about CCTV in the public realm due to privacy concerns.

IV: Another member of the public knew of another person not present who might repair the rotten stile, entrance to Essex Way.

The Public forum was closed, and the meeting opened.

2864: Minutes: The Minutes of the meeting held on Wednesday 8th January 2020 were agreed as a true record and signed.

2865: Matters Arising and Actions:

<u>i: Traffic Wheatsheaf Lane (2847)</u> Update from Parish Clerk: Panther Travel Ltd no known reported incidents since last meeting. Parish Council to keep in touch. **Action: Parish Clerk**

Update from Ms R Thornton: Essex Highways Liaison Officer suggested the Parish Council contacted the haulage companies. Late last year the Essex Highways Liaison Officer arranged a survey to be undertaken to measure the speed and volume of the HGV's. Ms Thornton did explain the speed wasn't the issue and was told by Essex Highways it's a procedure that needs to be undertaken before the main issue - the HGV's damaging the road and the safety to passing vehicles - could be taken further. When Ms Thornton asked this month what the next step would be, she was told there wouldn't be a next step. Following discussion it was decided that we request Essex Highways to a site meeting to witness the problem of large vehicles and inspect damage to the verges along Wheatsheaf Lane. Councillor Zoe Fairley to be copied in on the emails.

- 2866: Playing Field Oak Tree: Playing Field Oak Tree (2848) Three crown reduction quotations had been obtained from tree surgeons. It was agreed by all to go with Cochrane Tree services £600.00. Action: Mrs J Cole.
- 2867: Village Newsletter: The Wrabness Editor has resigned and Mr R Colley organised and published the last Parish Newsletter at short notice. An advert placed in the newsletter, advertising for a new editor for future editions, produced three volunteers. It was decided to draw a name out of hat and the next editor for Wrabness Newsletter will be David Todd. The volunteers will be contacted and thanked.

- **2868: Web Site:** Mr R Colley gave an update. The Wrabness Parish Council website has been operating since November 2013. A total of 8,858 visits were made to the site last year. Essex County Council informed users they will discontinue their support for the free essexinfo.net platform as from 31st March 2020 and advised all their users to make alternative arrangements. At the meeting on 20th November 2019, the Parish Council considered the options and decided to establish a replacement website for parish council business and village news. The Parish Council looked at the various options on offer and selected the BT Community Web Kit as a free of charge service for the replacement website. Mr Richard Colley volunteered to get it up and running.

Since then BT has agreed to host our new web site at no cost to the Parish Council and we have a new web address www.wrabness-parish-council.btck.co.uk The new website is under construction will be ready to launch during March. Viewing will be mobile phone friendly. Village organisations and clubs will continue to benefit from the free publicity if they wish to supply information. Examples of the web pages were tabled at the meeting. All agreed:

2669 Open space, land South of Station Road, Wrabness (2832) At the last meeting the Parish Council agreed in principle it is still interested to owning and managing the new open space providing it is gifted free of charge after it has been laid out for use. Tendring District Council are reviewing the relevant Section 106 agreement which currently states, 'Land will be laid out and managed by a resident management company' with the proposed change to 'Land laid out and given to the Parish Council'. All agreed we want to proceed and we will also ask to hold a meeting with the developer Bennet Homes to clarify the details of the arrangements.
