# WRABNESS PARISH COUNCIL

Minutes of the meeting held on Wednesday 20th March 2019 in Wrabness Village Hall at 7.30pm

2726: Apologies for absence: Mr T Harvey.

2727: Declaration of interests: Ms R Thornton item 2735.

2728: Minutes of the meeting held: on Wednesday 20th February. The Minutes were agreed as a true record and signed.

2729: Matters Arising and Actions:

i: <u>Playing Field</u>; Informal site review has been arranged with the Safer Communities Manager of Tendring District Council and a Police Community Support Officer. After the visit the Parish Council will receive a short report. **Action: Parish Clerk/Harry Jones.** 

ii: Increase Train Noise. Case has been closed but `Network Rail have encouraged residents to log a complaint if still a problem. **No further Action**.

iii. Traffic Wheatsheaf Lane. To be carried forward to next meeting. Action: Ms R Thornton.

iv: This Year Litter Pick: Mr H Jones gave a report. On March 9<sup>th</sup> a successful annual clear up took place with over 30 volunteers, including 8 under 16s. Soup and rolls were provided for the hard-working volunteers afterwards.

A thank you was given to Herman Ramsey for organising the soap and rolls.

v: Pre- Application for Local Service funds, submitted to EALC in March (W.P.F.A yearly ground maintenance) Local Service Fund is on hold and due to be re-launched on the 1st April. EALC are awaiting authorisation from Essex County Council on the new guidelines around the fund: Pending: **Action: Parish Clerk.** 

**2730: Presentation of Wrabness Environmental Award:** Mr. H Jones made the presentation of the 2019 Wrabness Environmental Award to Fiona Caslake in recognition of her hard work in managing the Village newsletter and Village Facebook page.

2731: Rural Services Network call on Government for a Rural Strategy:

On 1st March, the Rural Services Network launched a campaign calling on the Government to develop a Rural Strategy to ensure that rural areas are properly considered.

Rural Services Network has produced a report identifying several priority areas for a new Government Rural Strategy and some of the issues they have asked to be addressed, include:

- : Improve infrastructure and transport links, and raises the opportunities and challenges facing rural areas.
- : Provide rural businesses with the support they need to create thriving local economies.
- : Ensure all rural households and businesses have the option of reliable access to broadband and mobile networks.
- : Ensure opportunities for quality jobs, skills and training are available so young people can remain local.

**2732: The new refuse Collection Service.** Tendring District Council will begin to deliver wheelie bins to all suitable properties across Tendring from 10<sup>th</sup> June, a copy of the new waste service leaflet will be going out to all residents with their council tax bill.

Wheelie bin collections for household waste will be fortnightly, a small number of properties that are unsuitable for wheelie bins will remain on a weekly black sack collection.

Food waste, recycling and garden waste are unchanged.

2733: Planning Applications. Planning Application: 19/00367/FUL - The Priory Harwich Road Wrabness Manningtree Essex CO11 2UG: Proposed 4 no. four-bed detached dwellings with garages, amendment to existing access road plus provision of turning head. The proposal is contrary to the published Tendring District Local Plan. The proposed housing development is located well beyond the settlement limits for Wrabness and due to remoteness from village services is not a sustainable location for residential development. The proposed dwellings and the related highway proposals would intrude into the open countryside to the detriment of the local environment and create a precedent for further sporadic unsustainable housing development elsewhere along Harwich Road. All Agreed: Objection.

## **2734: ANY OTHER BUSINESS**

1: Recycling Bins: The Parish Council has had a request from a resident asking if we could contact Tendring District Council about re-introducing recycling bins in the village. This was looked into last year; no suitable location was found.

- 2: A resident has asked if the Parish Council could minute that the Wrabness Community Shop has a collection point for empty crisp packets, the empty packets are delivered to Wix & Wrabness Primary School. The school will receive money for the crisp packets.
- 3. Letter from a resident: A car travelling towards Harwich on the B1352 left the road on the sharp bend and went through their hedge and wire fence, then across their lawn into their neighbour's garden, then out onto the road. The residents feel if the bend warning sign had been in place this accident could have been prevented and are concerned further accidents could happen. They have contacted Highways about replacing the damaged bend sign. The sign has been down for 2 years. Mr Mark Cole will contact the Parishes District Councillor. **Action: Mr Mark Cole**
